COVAC GLOBAL Eligibility and Requirements

- Individual membership open to those 21 years and older.
- Family Memberships for immediate families without age restrictions for dependents/spouse, no limit on number of immediate family members.
- Family Members do not need to be traveling together or at the same time to receive benefits.
- Days can be used all at once or on several separate trips.
- Covac Global asks that members report travel outside of their home country by emailing or calling Covac Global Member Services to activate coverage 'days' prior to travel.

- Under 21 only on "Family" membership
- No trip longer than 14 days

TRAVELING OUTSIDE THE US

We handle all the logistics and costs of the transport from point of location all the way home (ground and air ambulance), with no geographic restrictions and a 24/7 operations center, if you have to travel - travel safe.
